#### Future actions.

To use contacts made within schools to launch a recruitment campaign for new Youth members after the summer School holidays which will involve our new engagement Officer.

Also to follow up with Children's Mental Health Team suggestions as to how our Youth members can be more proactive in the future . A suggestion was previously made of the possibility of training Peer workers to work within schools as a further preventative strand to prevent young people from the necessity of being formally officially referred to Mental Health Team.

Work closely with all agencies to ensure that our report has a positive affect on the quality of services provided for young People in Telford and Wrekin.
